- I. CALL TO ORDER Charlie Powell called the meeting to order at 1:10 p.m.
- II. OPENING PRAYER & PLEDGE Dann Baker led the audience in prayer, Robert Earley led the audience in the pledge to the flag.

IV. APPROVAL OF MINUTES

A. February 9, 2017
